EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:

- That immediate adoption, amendment, or repeal of a rule is necessary for the preservation of the public health, safety, or general welfare, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the public interest.
- That state or federal law or federal rule or a federal deadline for state receipt of federal funds requires immediate adoption of a rule.
- That in order to implement the requirements or reductions in appropriations enacted in any budget for fiscal year 2009, 2010, 2011, 2012, or 2013, which necessitates the need for the immediate adoption, amendment, or repeal of a rule, and that observing the time requirements of notice and opportunity to comment upon adoption of a permanent rule would be contrary to the fiscal needs or requirements of the agency.

Reasons for this finding: This emergency rule is needed to close the Icicle River which was opened by filing WSR 16-11-039. The spring Chinook run to the Icicle River has completed its return to the tributary. These fish will begin to spawn soon and will be largely undesirable as a food fish. There is insufficient time to adopt permanent rules.

WAC 220-310-19500H Freshwater exceptions to statewide rules—Eastside. (16-104)

EMERGENCY RULE ONLY

Reasons for this finding: This emergency rule is needed to close the Icicle River which was opened by filing WSR 16-11-039. The spring Chinook run to the Icicle River has completed its return to the tributary. These fish will begin to spawn soon and will be largely undesirable as a food fish. There is insufficient time to adopt permanent rules.
