General Conditions

Field trials will not be held on consecutive weekends at the Scatter Creek-South, Scatter Creek-North, or Davis Creek Unit. Dates closed due to this general condition are designated by "X".

Scatter Creek Unit – Limit of one (1) one field trial per weekend. Closed dates designated by "X".

South #1 - Field Trials are closed from the start of pheasant hunting season (see WDFW Migratory Waterfowl & Upland Game Seasons manual) through July 31 due to other recreational and wildlife management activities.

*From January 1 – March 31, WDFW may designate this site as the alternate for the Davis Creek Unit.

North #2 - Field Trials are closed from the start of pheasant hunting season through December 31.

Davis Creek Unit

Field Trials are closed from the first weekend in October through the second weekend in December due to other recreational and wildlife management activities.
