



# Covid-19 Economic Impact and Gov's Office Response

- Revenue outlook \$9B less than expected
- Hiring and Purchasing Freeze

   OFM directs agencies to
   freeze all hiring and purchases
   greater than \$5K
- Budget Savings for FY21 OFM directs agencies to identify 15% of reductions
- Furlough and COLA OFM directs agencies to furlough 20% in July, 1 day/month in fall, and eliminates 3% COLA for certain employees









### **WDFW Budget Overview**

### 2019-21 Operating Budget (dollars in millions)






#### 2017-19 Biennium Spending by Activity (dollars in millions)

Expiration of one-time funding

- 2019 SRKW investments (\$8.2M)
- 2020 Provisos- (\$3.5 M)
- (CR Pinniped, Green Crab, Net Ecological Gain, etc.) Resolution of Structural Deficit
- \$14.7M swap WL-S for GF-S
- Reversal of one-time investment from 2019 (\$24M)





#### **Operating Budget Requests**

# Three levels for budget

- Carryforward level technical only (No requests)
- Maintenance level for increased costs
- Performance level budget requests



## 2021 Second Supplemental Operating Budget Requests

 Second supplemental requests can only be onetime. We may see similar ongoing packages in the 2021-23 maintenance level requests.





## 2021 Second Supplemental Operating Budget Requests

- SB 5481 Interest Arbitration \$264k
- IT Reclass Appeals -\$172k
- Wildfire Habitat Recovery \$100k (placeholder)
- Office of the Attorney General 2% increase \$50K
