Background

The Fish and Wildlife Commission requested the Department to initiate rule making for an annual spring black bear special permit season that would start in 2022.

□ Mandate (RCW 77.04.012)

Game Management Plan (2015-2021)



Proposed Rule Changes WAC 220-415-080 Spring Black Bear Special Permits



Spring black bear special permits:

- Petition request to remove year from title of the rule
- WDFW staff included a take prohibition for female black bear with offspring and offspring.
- Request for potential delegation for rulemaking authority not in the CR102



Spring black bear special permits:

Proposal

- **Changes:** Remove the year from the title and adjust the season dates.
 - » Proposed season dates: May 1 June 15
 - » Hunt units would remain the same



Spring black bear special permits

Proposal:

- **Changes:** Reduce the number of permits from 10 to 6 in Hunt Unit 684 (Long Beach).
 - » Due to access and overcrowding
 - » October 20, 2022 Presentation, slide 17: GMU 684 - Reasons should include:
 - Human-bear conflict
 - » Total statewide 644 permits are proposed



Spring black bear special permits

Proposal:

- **Changes:** Add a provision prohibiting harvest/take of female black bear accompanied by offspring and harvest of offspring less than one year old or less than 50 pounds.
 - » Adds a definition of "offspring"
 - » Address public concerns, align with other western states and provinces that offer spring bear seasons.




Spring black bear special permits

Proposal:

- **Changes:** Add language associated with the harvest inspection.
 - » Unfrozen pelt and head with evidence of sex and head must be attached.
 - » Call within 72 hours to schedule inspection.
