Background summary:

Item 1: Proposed Acquisition of 94(+/-) acres in Grays Harbor County – Scatter Creek Wildlife Area, Davis Creek Unit

This proposal, in the Davis Creek Unit of the Scatter Creek Wildlife Area, is to acquire a 94(+/-) acre property of riparian and floodplain habitat along the Chehalis River. The riparian and floodplain habitats at this site are mixed with remnant Oak Woodland and historic prairie. Creating connectivity between the Capitol State Forest and the Lower Chehalis State Forest, the property supports waterfowl, elk, beaver, salmonids plus Species of Greatest Conservation Need (SGCN) listed band tailed pigeon and wood ducks. The endemic Olympic Mudminnow has also been found less than a half mile from the property. Opportunities for future restoration include reforesting the riparian corridor and placing large woody debris within the Chehalis River mainstem and off channel habitats. The site also contains opportunity for recreation including waterfowl hunting, wildlife viewing, bird watching and hiking.

Approved through Lands 20/20 in 2020, the appraised value of the property is \$565,000. This proposed acquisition will be funded through a Chehalis Basin Aquatic Species Restoration Plan and Washington Wildlife and Recreation Program – Riparian Protection grants.


