Name of Proposal: DNS 08-072: ROUTINE MAINTENANCE AND OPERATIONS AT
WDFW FINFISH HATCHERIES AND REARING PONDS

Description of Addendum 22-026:

The original project and other elements of the proposed work have been modified as indicated below in underlined red font.

Additional locations and activities have been added to the original proposal, see attached table. These activities include temporary resistance board weirs operated in four additional watersheds. The operation of temporary resistance board weirs plays a critical role in limiting the number of hatchery origin salmonids on the spawning grounds for the benefit of ESA listed stocks.

No changes to the existing checklist were made because the scope of work and operation of these types of projects has not changed.
