DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: DNS 22-031: LISTING CHANGES FOR CASCADE RED FOX AND

AMERICAN WHITE PELICAN IN WASHINGTON STATE

Description of Proposal:

Washington Department of Fish and Wildlife (WDFW) proposes to change the listing status of two species in Washington State:

• List Cascade Red Fox as State Threatened.

• Downlist American White Pelican from State Threatened to State Sensitive.

Changes to the listings for the two species are supported by a Status Report for the Cascade Red Fox and a Periodic Status Review for the American White Pelican. The environmental impacts are analyzed in two separate Environmental Checklists.

Under WAC 197-11-060(3)(b) and (c), WDFW is issuing one Determination of Non-Significance for the changes to the listings for the two species because there is one proposed action: changing WAC 220-200-100 to add the proposed new listing status for both species. This proposal is considered to be a single course of action. WDFW is also incorporating both reports by reference.
