#### April 8, 2022

Chair Baker called the meeting to order at 8:00 a.m.

#### 1. Call to Order

#### a. Commissioners' Discussion

The Chelan River Rulemaking Delegation – Briefing, Decision item has been struck from the agenda and will be addressed at a future meeting.

Commissioner Anderson shared his experience netting and tagging cutthroat trout on Lake Lenore.

Commissioner Lehmkuhl shared a cougar experience on his property.

Commissioner Rowland shared her experience with the Ephrata office field trip in March. Commissioner Lehmkuhl was also in attendance.

Commissioner Smith attended the WAFWA Mountain Lion Workshop and shared items of interest from the event.

#### b. Meeting Minute Approval

The Commission considered approval of the March 17-19, 2022, webinar and April 1, 2022, draft special web conference minutes.

Commissioner Thorburn made motion, seconded by Commissioner Smith, to approve the minutes of the March 17-19, 2022, webinar as presented. All in favor. Motion passes.

Commissioner Thorburn made motion, seconded by Commissioner Smith, to approve the minutes of the April 1, 2022, special web conference as presented. All in favor. Motion passes.

c. Committee Reports - This Section constitutes the formal minutes from each of the listed committee meetings:

#### **Big Tent Committee**

Commissioners in attendance: Committee members Thorburn, Baker, McIsaac, and Commissioners, Smith, Anderson, Lehmkuhl, Rowland, and Ragen

Commissioner Thorburn reported that Nate Pamplin, Policy Director provided an update on the Communications and Public Engagement Assessment. He also briefed the committee on the status of some near-term actions within the 25-year Strategic Plan strategy to Engage Communities through Recreation and Stewardship. Commissioners noted the importance of the Commission forum as an outreach/engagement platform and discussed ideas for improving the synthesis of public comments received at Commission meetings.

Jeff Davis, Conservation Director briefed the committee on an approach to develop a conservation roadmap—to connect broader conservation work and objectives, by WDFW and partners, across Washington state. The agency is scheduling a conference with partners to develop shared goals and priorities, with the idea to create a collective long-term conservation agenda.

Chair Baker requested that the next committee meeting in June discuss the following items with the allotted times. RAWA (30 minutes), Conservation Roadmap process (30 minutes) and the Conservation Policy (60 minutes). Materials for the committee meeting can be found on the meeting agenda here.

#### **Fish Committee**

Commissioner McIsaac reported that the committee struck the Pinto Abalone Recovery Plan from the committee discussion due to time constraints. The committee was also provided a Pound Net (Blue sheet) overview, discussed the Policy C-3624 implementation report that will be provided to the full commission and under general discussion – current events, staff provided a Grays Harbor Coho impact rate change briefing that required a recommendation for the full commission. Craig Burley, Deputy Director, Fish Program, updated the committee on the Chelan petition that will be brought to the Commission for additional guidance. After discussion the committee supported the staff recommendation for the Grays Harbor Coho impact rate change and the committees supported striking the Chelan petition adjustments from the Commission agenda for a later date. Following delivery of the Fish Committee report to the Commission, Commissioner McIsaac made a motion, seconded by Commissioner Smith, for 2022 only, to approve delegation to the Director to negotiate optimal fisheries for the Grays Harbor area in accordance with the Grays Harbor Salmon Management Policy (Policy C-3621), with the exception of the 5% fishery impact ceiling applicable to coho salmon referred to in the Adaptive Management section. All in favor. Motion passes.

Commissioner McIsaac made a motion, seconded by Commissioner Thorburn to adopt the recommended rule changes to WAC 220-413-060 Hunting restrictions as presented by Department staff. The Commission discussed the motion. All in favor. Motion passes.

Commissioner McIsaac made a motion, seconded by Commissioner Linville to adopt the recommended rule changes to WAC 220-414-010 Hunting equipment restrictions as presented by Department staff. The Commission discussed the motion. All in favor. Motion passes.

Commissioner Anderson made a motion, seconded by Commissioner Lehmkuhl to adopt the recommended rule changes to WAC 220-414-060 Muzzleloading firearms as presented by Department staff. The Commission discussed the motion. The motion failed with 6 votes in against, Commissioners McIsaac, Baker, Ragen, Rowland, Smith, and Linville and 3 in favor, Commissioners Thorburn, Anderson, Lehmkuhl.

Commissioner Rowland made a motion, seconded by Commissioner Linville to adopt only subsection (1)(a) of the proposed amendments to WAC 220-414-060 Muzzleloading firearms as presented by Department staff. The Commission discussed the motion. The motion passes with 7 in favor, Commissioners Baker, Ragen, Rowland, Smith, Linville, Anderson and Thorburn with 2 against, Commissioners McIsaac, Lehmkuhl.

Commissioner Thorburn made a motion, seconded by Commissioner Anderson to adopt the recommended rule changes to WAC 220-413-090 Field identification of wildlife –Evidence of sex-Definitions and WAC 220-414-020 Unlawful methods for hunting – Firearms as presented by Department staff. The Commission discussed the motion. All in favor. Motion passes.

Commissioner Rowland made a motion, seconded by Commissioner Ragen, to adopt only subsection 1(f) of the proposed amendments to WAC 220-414-070 Archery requirements as presented by Department staff. The Commission discussed the motion. The motion passes with 5 votes in favor, Commissioners Baker, Ragen, Rowland, Smith, and Linville, McIsaac and 4 against, Commissioners Thorburn, Anderson, Lehmkuhl.

Commissioner Anderson made a motion, seconded by Commissioner Thorburn to adopt the recommended rule changes to WAC 220-414-100 Crossbow requirements as presented by Department staff. The Commission discussed the motion. The motion failed with 5 votes against, Commissioners McIsaac, Ragen, Rowland, Smith, and Linville and 3 in favor, Commissioners Thorburn, Anderson, Lehmkuhl.

### 15. Chronic Wasting Disease – Decision

Kyle Garrison, Acting Ungulate Section Manager asked the Commission for a decision on WAC 220-413-030 Importation and retention of dead nonresident wildlife.

Commissioner Smith made a motion, seconded by Commissioner Rowland to adopt the recommended rule changes as presented by Department staff. All in favor. Motion passes.
