


WDFW Oyster Drill Restricted Areas


The following areas have a documented presence of Japanese or Eastern oyster drills, non-native pests to Washington shellfish and marine ecosystems. WDFW restricts or conditions shellfish, gear, and other transfers originating from these areas to reduce risk of spreading these pests around state waters. Accidental spread through human activity is the primary means of these species' spread (they do not have a swimming larval stage like some other species), and so it is important to use precaution in managing shellfish, gear, and other transfers or movements from within these areas. A WDFW shellfish transfer permit is required for all shellfish transfers within state waters.




North Puget Sound - Drayton Harbor




North Puget Sound - Birch Bay














Strait of Juan De Fuca - Dungeness Bay




Hood Canal - Quilcene Bay






Hood Canal - Point Whitney




Hood Canal - Tarboo Bay




Hood Canal- Guillemot Cove Restricted Area




Hood Canal - Dosewallips Delta to North Boundary Seal Rock Camp Ground




Hood Canal - Duckabush Delta




Hood Canal - Hama Hama Delta - Jorsted Creek




Hood Canal - The Great Bend - Lynch Cove




Central Puget Sound - Liberty Bay




Central Puget Sound - Dyes Inlet




South Puget Sound - Carr Inlet - Burley Lagoon




South Puget Sound - Carr Inlet - Minter Creek






South Puget Sound-Hammersley Inlet Oakland Bay Restricted Area


