# 3. Director's Report

Director Susewind provided an overview of current events, activities, and meetings of impact within and in relation to the agency.

The following items were highlighted:

- In-person on regional award ceremonies will be held two weeks in August.
- Centennial Accord is scheduled at Tulalip on October 24 & 25.
- 2024 WAFWA meeting will be in Washington and likely in region 5.

## **Fire Update**

After a cooler and moister spring and early summer the department implemented emergency rules on July 15 in eastern Washington, two weeks later than normal, to reduce the risk of wildfire. Emergency rules included restrictions on campfires, target shooting, and more. Wildfire risk is now more typical for this time of year being very high in most of eastern Washington. Three significant

wildfires have impacted WDFW lands with two currently burning on both the LT Murray Wildlife Area and the Wenas Wildlife Area.

#### **Bear-Human Encounter**

On Wednesday, Aug. 3 at approximately 8:30 a.m., Washington Department of Fish and Wildlife (WDFW) Officers received a report of a human-black bear incident in Whatcom County. The person involved sustained multiple injuries to his hands and feet and received medical care at a local hospital. The bear was lethally removed from the area. In Washington state, the only recorded fatal black bear attack on a human was reported in 1974. Since 1970, state authorities have recorded 18 other human-black bear encounters that resulted in a documented injury. The most recent was in 2015.

# 4. Land Transactions - Briefing, Public Comment, and Decision

Karen Edwards, Real Estate Manager asked the Commission for approval of a land transaction recommended by the Department for the enhancement of conservation and public recreation opportunities.

There was no public comment on this item.

Commissioner Rowland made a motion, seconded by Commissioner Ragen to approve the land transactions as presented by staff. All in favor. Motion passes.

# 5. 2023 Agency Request Legislation – Decision

Tom McBride, Legislative Director asked the Commission for a decision on the agency's request for legislation for the 2023 legislative session.

Commissioner Smith made a motion, seconded by Commissioner Ragen to approve the proposed agency request legislation as presented. All in favor. Motion passes.

## 7. 2023-25 Operating and Capital Budgets - Decision

Morgan Stinson, Chief Financial Officer, and Tim Burns, CAMP Program Director asked Commission for a decision on the proposed FY23-25 Operating and Capital Budgets.

Commissioner McIsaac made a motion, seconded by Commission Anderson to approve the proposed 2023-25 operating budget request as presented by staff, with allowance for minor adjustments as staff prepares final documents for submittal to the Office of Financial Management, which included Commissioner McIsaac's further explanation about how "minor adjustments" should be interpreted to include a restriction on certain use of funds.

The Commission discussed the motion.

Commissioner Smith made a motion, seconded by Commissioner Rowland to amend the initial motion to remove Commissioner McIsaac's further explanation and intended restriction.

The Commission discussed the motion to amend.

After further discussion, Commissioner Smith and Rowland withdrew their motion to amend, and Commissioner McIsaac and Anderson then withdrew their motion.

Commissioner McIsaac made a new motion, seconded by Commission Anderson to approve the proposed 2023-25 operating budget request as presented by staff, with allowance for minor adjustments as staff prepares final documents for submittal to the Office of Financial Management. All in favor. Motion passes.

Commissioner McIsaac made a motion, seconded by Commissioner Anderson to approve the proposed 2023-25 capital budget request as presented, allowing for minor adjustments to the project scope and budget to the Office of Financial Management. All in favor. Motion passes.

# 8. Roadkill and Salvage Petition - Briefing, Decision

Anis Aoude, Game Division Manager asked the Commission for a decision on a petition to amend WAC 220-413-030 to, "be more in line with the current Idaho Roadkill and Salvage rules."

Commissioner Smith made a motion, seconded by Commissioner Ragen to deny the petition with the understanding that there will be a future conversation about animal dispatch practices. The majority were in favor except for Vice Chair Linville who voted against it. Motion passes.
