## Forest Management Strategy

- Strategy adopted in 2014
- Forests managed for ecological integrity
- Requires forest management plan for each wildlife area
  - Will provide more accurate forest information
  - Will define areas for priority projects

#### Recreation Management Strategy

- Provide guidance and tools to evaluate impacts of nonwildlife related recreation uses
- Develop standards for maps, signage and other public information, including disabled access
- Draft expected in 2015




