- Methods were chosen to reduce the expansion factor and produce the most accurate estimate possible
- Logistics of each fishery were considered when determining most appropriate methods
 - Timing and duration, geography, other fisheries, harvester density, etc.

SHRIMP FISHERY TOPICS - Commercial Shrimp Fisheries

- Spot (pot):
 - 4,500 lbs initial share per license 3,000 lbs limit through July 13
 - Increased to 5,000 lbs total on August 4
 - Additional mop up started August 24
 - 2E, 3, 4 (26C) , 6 (26D)
 - Required declarations
 - Date, Target Species, Target Pounds, Area
 - Opened 5/1/2021, closed 9/13/2021
- Non-spot (pot)
 - 600lbs weekly limit in 1, 2E, and 2W. Increased to 1000lbs weekly limit July 14
 - No weekly limit in harvest from Region 3. Subareas of 23A opened as spot harvest was closed in those area
 - Required declarations Date, Target Species, Target Pounds, Area

2022 Season Discussion

- Impacts of overages in Hood Canal and Elliot Bay
 - Only 1,022 lbs of 5,500 usual share in Elliott Bay for 2022
 - 7,481 lbs over in Hood Canal (about 1/2 weekday)
- 2 pots per boat as a management tool
 - Used for 2 days in 8-1/8-2 this year
- Fishery days/hours/start date
 - Best initial weeks around Wed May 11 and Wed May 25
 - Why are weekend days hard to accommodate in many areas?
 - Limited by days creelers are available
- Update on rule to allow discard of heads when harvesting spots

Commercial harvest data through 10/10

- Winter recreational season rare in MA 10
 - Since 2010 only had winter seasons in 2010 (49d), 2015 (31d) and 2016 (32d)
- Some options for winter recreational with ~19,000 lbs remaining
 - Opening to capture Thanksgiving and Christmas
 - Opening to capture Thanksgiving or Christmas only (most conservative)
 - November and December opening (least conservative)

State commercial update

- Delayed opening beginning Oct 7 instead of Oct 1
- New tools for tracking harvest and effort
 - WATIX (electronic fish tickets)
 - Hung crab reports
 - Fishing declarations
- Access to old "non-commercial" and limited commercial zones

2022 season and beyond

- Adding online resources to educate crabbers
 - Re-establishing "Frequently Asked Questions" page
 - Crabber quiz
 - Updating formerly downloadable pdfs
- CRC reporting
 - What are the barriers (Doc ID requirement, password requirement, CRC on boat, etc.)
 - What are best tools to increase % reporting?
- Getting final summer recreational estimates earlier
- In-season softshell sampling and potential impacts
 - Softshell percentage can vary greatly during year in 8-1/8-2
 - Closures would likely apply to all crab fisheries
- Shifting more enforcement effort to open day patrols

2022 season and beyond

- CRC recording compliance and updating bias correction
 - Tasks being undertaken
 - Anticipated staff and funds
- Constraints of current crab policy
 - Specifies application to Dungeness crab
 - No provisions for State commercial opportunity in many areas
- Offering a Red Rock crab only opportunity in MA 11, 12 south, 13.
 - Allowed methods and areas if pursued
 - Options for tracking recreational harvests
 - Crab endorsement would NOT be required
