Increased Opportunity

- Blue Mountains special permits for bulls.
- Yakima special permits for bulls.
- Increased antlerless special permits in some of the Yakima units.
- Increase in bull permits for Nooksack.


Selkirk Elk

- Recommend changing GMUs 101, 105, 108, 121, and 204 from "any elk" to "any bull" seasons.
- Intention is to promote growth in the elk population and create more elk hunting opportunity in the future.
- Eliminate "any elk" Master Hunter hunt in GMUs 127-142.
- Retain "antlerless" Master Hunter hunt in GMUs 127 and 130.


Colockum Elk




Colockum Herd Size



Colockum Bull Population




Colockum Cow Population



Colockum Post-Hunt Bull:Cow Ratios


March Bull:Cow Ratios

- Percent Yearling Bulls Harvested Under Spike Only Management (SOM)
 - Colockum ~82%
 - Yakima ~70%
 - Blue Mountains ~60%
 - Colockum Under True Spike ~66%

Colockum Elk

- Colockum special permits for bulls.
 - Increase modern firearm from 3 permits to 8 permits.
 - Increase archery permits from 2 permits to 6 permits.
 - Maintain muzzleloader permits at 1.
 - Overall increase from 6 permits to 15 permits for bulls.
- Goal is to return total population to objective.
- Antlerless opportunity for Colockum
 - General season: late archery GMUs 328, 335
 - Special permits
 - GMUs 328, 329 create 40 permits modern, 50 archery and 30 muzzleloader. Harvest target ~ 75
 - GMU 335 reduce from 50 to 30 permits

Floor Amendments

- Page 34: Change the number of permits for Nooksack, WF, Oct. 8-Nov. 16, Any bull, from 4 permits to <u>5 permits</u>.
 - March flights confirmed more bull permits could be offered in the Nooksack unit.

 Page 35: Change the dates for Peninsula WF (GMUs 602, 607, 612), Quinault WF (GMU 638), and White River WF (GMU 653) hunts from Sept. 16-20 to Sept. 24-28.

 These three changes eliminate overlaps between modern firearm special permit hunts and archery deer and elk general seasons.

Floor Amendments

- March flights confirmed more bull permits could be offered in the Nooksack unit.
- Page 35: Change the number of permits for Nooksack, WA, Sept. 1-23 and Dec. 1-31, Any bull, from 2 permits to <u>3 permits</u>.
- Page 36: Change the number of permits for Nooksack, WM, Sept. 24-Oct. 7 and Nov. 24-30, Any bull, from 2 permits to <u>3 permits</u>.
- Page 37: Change the number of permits for Nooksack, WA, Sept. 1-23 and Dec. 1-31, Spike only from 2 permits to <u>3 permits</u>.
- Page 38: Change the number of permits for Nooksack, WM, Sept. 24-Oct. 7 and Nov. 24-30, Spike only, from 2 permits to <u>3 permits</u>.
