### Hunters with Disabilities Purpose of Changes

- Address a petition to the Commission to modify rules for hunters with disabilities and their ability to use crossbows equipped with scopes during archery seasons
- Delegate to the Department the authority to condition equipment modifications through Special Use Permits

#### Assurances

Each recipient of a grant from WSFR, as a condition for receiving that grant, has to sign an assurance that it will not discriminate against public participants in their programs and activities—that means nondiscrimination on the basis of race, color, national origin, age, disability, and sex (in education programs).

### Assurances (cont.)

All sub-grantees and subcontractors of the agency must sign an assurance that they will abide by the covered Federal civil rights laws. The laws are to be listed in the assurance, and reflect the same assurances that the agency signs with FWS. This assures accountability at all levels of program operations.

# **Basic Authorities (cont.)**

All programs, activities, services and facilities of a recipient are covered – not just those receiving the direct federal funding.

#### **Basic Authorities Required (with exceptions)**

 Integrated programs access in both Structural (architectural) and

Non-Structural (policies and effective communication)

### Exceptions

All programs and activities must be accessible to persons with disabilities.

- Undue burden
- Fundamentally alters the nature of the program
- Viewing program in its entirety

#### **Accessible Recreation**

 A current lack of scoping requirements for certain recreation programs and facilities leave room for interpretation by Federal agency with jurisdiction (i.e. hunting and fishing programs, boat slips, trails, campsites, beach access, boat launches, fishing areas, etc.)

# Reasonable Modification Consideration

#### Non-Structural

- Policies and procedures to obtain services
- Hunting and fishing equipment
- Interpreters and readers
- Large print materials
- Personal services for child care programs
- Assistive devices (i.e. TTY's, Audio tapes, Captioning, Braille Signage)
- Staff Training
- Chemical Sensitivity
- Service animals

### Accessibility vs. Conservation

- Wilderness areas/closed
- Equivalent facilitation (equal experience at alternative location)
- Permit to hunt from a stationary vehicle
- Off-road vehicle (limited use)
- Accessible hunting blinds, fishing piers, boat ramps
- Case-by-case: recreational access is evolving
- Use of spin casting rods and reels vs. traditional fly fishing rods and reels

#### Public Civil Rights Complaint Process

- Who can file a civil rights complaint
- Are there time limits for filing complaints
- Where should I send my complaint
- What happens after I file a complaint
- Am I protected from retaliation if I file a civil rights complaint

### **WDFW Accomplishments**

- Archery hunting program rules allow for use of crossbows for persons with disabilities
- Special use Permits to hunt from motor vehicles
- Accessible hunting blinds
- Hunter companion card allow companion to shoot game for persons who are blind
- Manage the Becoming an Outdoor Woman Program
- Annual Kids Fishing days include wheelchair accessible waters at hatcheries (i.e. Merwin FH)
- Develop with Stakeholders Tribal/Non Tribal school curriculum

#### WDFW Accomplishments (cont.)

- Special use permit for fly fishing only waters
- Target schools with minorities
- Hunter Education manuals and tests provided (LEP – Spanish, Vietnamese)
- Construction of accessible fishing platforms (i.e. Blue Creek/Cowlitz Trout Hatchery)
- Creation of Disability Regional Advisory
- Developed Accessible Recreation Guide
- Special access to designated road by persons with disabilities

RCW 77.04.012

Mandate of department and commission.

- The commission, director, and the department shall preserve, protect, perpetuate, and manage the wildlife...
- The commission shall attempt to maximize the public recreational ...hunting opportunities of all citizens, including juvenile, disabled, and senior citizens.

#### RCW 77.04.150

Hunters and fishers with disabilities — Advisory committee...

 The commission must appoint an advisory committee to generally represent the interests of hunters and fishers with disabilities on matters including, but not limited to, special hunts, modified sporting equipment, access to public land, and hunting and fishing opportunities...

#### RCW 77.32.237

Disabled hunter permits for persons with a disability.

- The commission shall attempt to enhance the hunting opportunities for persons with a disability
- ...to issue disabled hunter permits to persons with a disability.
- ...shall adopt rules governing the conduct of persons with a disability who hunt and their designated licensed hunter.

#### RCW 77.32.238

Adoption of rules defining a person with a disability — Shooting from a motor vehicle — Assistance from licensed hunter.

 The commission shall adopt rules defining who is a person with a disability and governing the conduct of persons with a disability who hunt and their designated licensed hunters...

#### RCW 77.32.480

Reduced rate licenses.

 ...all hunting licenses shall be issued at the reduced rate of a youth hunting license fee for the following individuals:

(a) A resident sixty-five years old or older who is an honorably discharged veteran of the United States armed forces having a service-connected disability;

(b) A resident who is an honorably discharged veteran of the United States armed forces with a thirty percent or more serviceconnected disability;

#### RCW 77.32.480

Reduced rate licenses.

 …all hunting licenses shall be issued at the reduced rate of a youth hunting license fee for the following individuals:

(c) A resident with a disability who permanently uses a wheelchair;

(d) A resident who is blind or visually impaired; and

(e) A resident with a developmental disability as defined in RCW 71A.10.020 ...

Hunters with Disabilities Hunter Demographics

- Active disabled hunter permits 18,916
- Number who hunted deer in 2012 –7,455
- Number who hunted elk in 2012 5,535
- Number who purchased archery tags 1394
- Number of active Special Use Permits for using a crossbow - 1045

Hunters with Disabilities Hunter Demographics

- Number who harvested deer in 2012 1,953
- Number who harvested elk in 2012 588
- 2492 applied for a deer permit and 1055 were drawn or 42%
- 3211 applied for an elk permit and 799 were drawn or 25%

Hunters with Disabilities Options and Opportunities

- Shoot from a vehicle/hunter companion
- Special Use Permits
- Road Access Program
- Accessible blinds for waterfowl hunting
- Any whitetail or antler restricted plus antlerless general season dates in E. Wash.
- Antlerless deer and elk permits throughout the rest of the state
- A few antlerless moose permits

# Hunters with Disabilities Game Management Plan Priorities

- Hunter recruitment and retention
- First time hunter recruitment
  - Locavores, women, baby boomer's kids
- Retention of current hunters
  - Lapsed or periodic hunters,
  - Senior hunters,
  - Hunters with disabilities

### Hunters with Disabilities What's Next???

- Expand motorized access to private lands
- Ask landowners experiencing damage if they have harvest opportunities for those with disabilities
- Next three year package:
  - Increase the number of deer and elk permits consistent with the growth in hunters with disabilities
  - Consider "any" deer or elk opportunities in areas with antler restrictions if appropriate
- Other ideas ???

Hunters with Disabilities Special Use Permits Proposal

- Special Use Permits to address needs such as crossbows for disabled archers; scopes for muzzleloaders; other adaptive equipment
- Delegate development of criteria and issuance to the Department
- In concert with the Commission's Fishers and Hunters with Disabilities Advisory Group
