Policy issue(s) you are bringing to the Commission for consideration:

Protecting critical fish and wildlife habitat, providing public recreational opportunity, and responsible property management.

Public involvement process used and what you learned:

Item 1 – This acquisition of a conservation easement is part of the Methow Watershed project which was evaluated and approved through the Lands 20/20 process. This action will be funded by a grant from the Washington Wildlife and Recreation Program and USFWS section 6 program. Authority for this acquisition is provided in the capital budget.

Item 2- This acquisition of a conservation easement is part of the Methow Watershed project which was evaluated and approved through the Lands 20/20 process. This purchase will be funded by a grant from the U.S. Fish and Wildlife Service Section 6 program. Authority for this acquisition is provided in the capital budget.

Item 3 and Item 4 – These acquisitions are part of the Cowiche Watershed project and have been evaluated by the Department Lands 20/20 process. This purchase will be funded by mitigation funding through the Dept. of Ecology.

SUBJECT: ITEM 1: PROPOSED ACQUISITION OF THE SILVER SIDE

CHANNEL PROPERTY CONSERVATION EASEMENT, GOLDEN DOE UNIT, METHOW WILDLIFE AREA, OKANOGAN COUNTY

The Washington Department of Fish and Wildlife (WDFW) has secured an option to purchase a conservation easement on approximately 86.25 acres, known as Silver Side Channel Property. This acquisition is part of the Methow Watershed project which was evaluated and approved through the Lands 20/20 process. This action will be funded by a grant from the Washington Wildlife and Recreation Program and the U.S. Fish and Wildlife Service. Authority for this acquisition is provided in the capital budget.

This property is located in the Methow Valley, approximately four miles south of Twisp and is bounded on the east by Highway 153 and on its west by WDFW lands. The terms of the conservation easement prohibit subdivision, restrict development, restrict grazing to a level described as "slight", being 1% -20% use, defined as, "Practically undisturbed. Only choice areas and choice forage grazed.", and allow for fencing of the riparian area to protect the conservation values of the property. The property has approximately one half mile of frontage on a side channel of the Methow River, referred to as the Silver Side Channel. Protecting this property with a conservation easement will provide substantial long term protection for listed steelhead, spring Chinook and bull trout, and preserve it for wildlife movement, including migratory mule deer.

The conservation easement will be managed within the Wildlife Program as part of the Golden Doe Unit, Methow Wildlife Area. Because this is a conservation easement, there are no operation and maintenance costs. However, monitoring costs are estimated at \$750 annually. Funding will be provided from the existing wildlife area budget.

The Department has secured an option to purchase this conservation easement at the reviewed and approved appraised value of:

86.25 acres for \$550,000.00

The Department recommends the Commission approve the acquisition of the 86.25-acre Silver Side Channel property conservation easement for the appraised value of \$550,000.00.







SUBJECT: ITEM 2: PROPOSED ACQUISITION OF THE MALTAIS PROPERTY CONSERVATION EASEMENT, METHOW UNIT, METHOW WILDLIFE AREA, OKANOGAN COUNTY

The Washington Department of Fish and Wildlife (WDFW) has secured an option to purchase a conservation easement on 232.97 acres of the Kim Maltais property. This acquisition is part of the Methow Watershed project which was evaluated and approved through the Lands 20/20 process. The purpose of the project is to protect forest land, riparian and in-stream habitats, and key migration routes for mule deer in the Methow Watershed. This purchase will be funded by a grant from the U.S. Fish and Wildlife Service Section 6 program. Authority for this acquisition is provided in the capital budget.

This property is located in Methow Valley, approximately 6 miles east of the town of Twisp. The property consists of forested hillsides sloping to Fraser Creek and Highway 20, across the highway from the Methow Wildlife Area, adjoining other lands this landowner recently conveyed to WDFW. The property is currently used primarily for recreation and wildlife habitat, but it has a high potential for conversion to subdivision and residential development. The current owner prefers WDFW acquire a conservation easement on the property, forever protecting the wildlife habitat. The conservation easement will prohibit subdivision and development, require a Timber Management Plan for timber harvests, and restrict grazing to a level described as "slight", being 1% -20% use, defined as, "Practically undisturbed. Only choice areas and choice forage grazed." This acquisition will protect the wildlife habitat benefits, which include migration corridor for large mammals, forest land, riparian and in-stream habitats.

The conservation easement will be managed within the Wildlife Program as part of the Methow Unit, Methow Wildlife Area. Because this is a conservation easement, there is no operation and maintenance costs. However, monitoring costs are estimated at \$750 annually. Funding will be provided from the existing wildlife area budget.

The Department has secured an option to purchase this conservation easement at the reviewed and approved appraised value of:

232.97 acres for \$755,000.00

The Department recommends the Commission approve the acquisition of the 232.97-acre Maltais property conservation easement for the appraised value of \$755,000.00.







YAKIMA COUNTY

The Department of Fish and Wildlife (WDFW) proposes to purchase the 2,588.27-acre Tieton Cattle Association, Inc. property in Yakima County. This property has been evaluated and approved through the Lands 20/20 process for acquisition. Funding for the project comes from Department of Ecology and Kennewick Irrigation District to mitigate for shrub steppe losses due to conversion to irrigated agriculture, as a result of the Columbia River Project. Authority for this acquisition is provided by the capital budget.

This property is within the Cowiche Project Envelope, north and west of the City of Yakima, and nestled between the Oak Creek Wildlife Area and the Wenatchee National Forest. It is adjacent to the Corrado/Rightmire property also proposed at this time for WDFW acquisition. Acquisition of this property will complement the existing wildlife area; protect a large area of high quality shrubsteppe habitat, benefiting elk, mule deer and big horn sheep; and protect significant wildlife migration corridors. The property will be subject to an existing cattle grazing lease, until November, 2018, and will be subject to a cattle grazing easement that assigns the grazing management of the property to the Cowiche Canyon Conservancy (CCC). Grazing of the property will not exceed a degree of use described as moderate, being 21-40% use, defined as: "Most of the accessible range shows grazing. Little or no use of poor forage. Little trailing to grazing." Grazing activities must be consistent with, and are subject to, the overall management of the Property for habitat protection and restoration, and CCC will work with WDFW in developing a grazing management plan. The Rocky Mountain Elk Foundation secured this opportunity for WDFW and CCC.

The property will be managed within the Wildlife Program as part of the Oak Creek Wildlife Area. Operation and maintenance costs are anticipated to be \$20,700 annually to WDFW to address weed control and litter issues. Payments in lieu of property tax are estimated at \$2590. Funding will be provided from the existing wildlife area budget.

The Department has secured an option to purchase this property at the reviewed and approved appraised value of: \$1,380,000.00 for 2,588.27 acres

This appraised value includes the value of the grazing easement being granted to CCC. The Department recommends the Commission approve the acquisition of the 2,588.27-acre Tieton Cattle Association, Inc. property for the appraised value of \$1,380,000.00, subject to the CCC grazing easement.







SUBJECT: ITEM 4: PROPOSED ACQUISITION OF THE CORRADO/RIGHTMIRE PROPERTY, OAK CREEK WILDLIFE AREA, YAKIMA COUNTY

The Department of Fish and Wildlife (WDFW) proposes to purchase the 305.08-acre Corrado/Rightmire property in Yakima County. This property has been evaluated and approved through the Lands 20/20 process for acquisition. Funding for the project comes from Department of Ecology and Kennewick Irrigation District to mitigate for shrub steppe losses due to conversion to irrigated agriculture, as a result of the Columbia River Project. Authority for this acquisition is provided by the capital budget.

This property is within the Cowiche Project Envelope, north and west of the City of Yakima, and nestled between the Oak Creek Wildlife Area and the Wenatchee National Forest. It is adjacent to the Tieton Cattle Association property also proposed at this time for WDFW acquisition. Acquisition of this property will complement the existing wildlife area; protect a large area of high quality shrub-steppe habitat, benefiting elk, mule deer and big horn sheep; and protect significant wildlife migration corridors. The property will be subject to an existing cattle grazing lease to a long-time grazing tenant, until November, 2018, and will be subject to a cattle grazing easement that assigns the grazing management of the property to the Cowiche Canyon Conservancy (CCC). Grazing of the property will not exceed a degree of use described as moderate, being 21-40% use, defined as: "Most of the accessible range shows grazing. Little or no use of poor forage. Little trailing to grazing." Grazing activities must be consistent with, and are subject to, the overall management of the Property for habitat protection and restoration, and CCC will work with WDFW in developing a grazing management plan. The Rocky Mountain Elk Foundation secured this opportunity for WDFW and CCC.

The property will be managed within the Wildlife Program as part of the Oak Creek Wildlife Area. Operation and maintenance costs are anticipated to be \$2440 annually to WDFW to address weed control and litter issues. Payments in lieu of property tax are estimated at \$305. Funding will be provided from the existing wildlife area budget.

The Department has secured an option to purchase this property at the reviewed and approved appraised value of:

\$170,000.00 for 305.08 acres

This appraised value includes the value of the grazing easement being granted to CCC. The Department recommends the Commission approve the acquisition of the 305.08-acre Corrado/Rightmire property for the appraised value of \$170,000.00, subject to the CCC grazing easement.




