Chair Smith called the meeting to order at 7:59 a.m.

#### 1. Call to Order

## Commissioner Thorburn moved, seconded by Commissioner Kehoe to approve the minutes from the July 15, 2016 conference call as proposed. Motion passed.

#### 2. Open Public Input

#### 4. Hatchery Reform Policy C-3619 – Briefing

Kelly Cunningham, Deputy Assistant Director, Fish Program and Eric Kinne, Hatchery Systems Manager provided a briefing as stipulated per Policy C-3619 on the progress of implementing statewide hatchery reform in compliance with standards set by the Hatchery Scientific Review Group to further the recovery of wild salmon and steelhead populations while continuing to support sustainable fisheries.

#### 5. Willapa Bay Hatchery Evaluation - Briefing

Chad Herring, Willapa Bay Policy Implementation Biologist provided a comprehensive review of the hatchery programs in the Willapa Bay region as stipulated per Policy C-3622.

#### 6. Lake Roosevelt Trout Rule Change – Briefing and Public Hearing

Chris Donley, Region 1 Fish Program Manager provided the Commission with a briefing on the proposed changes to the Lake Roosevelt Trout.

No one signed up to provide testimony.

#### 7. Pacific Halibut Management Overview – Briefing

Michele Culver, Regional Director and Heather Reed, Coastal Marine Policy Coordinator briefed the Commission on the management of Pacific halibut, including the International Pacific Halibut Commission process, Pacific Fishery Management Council's Catch Sharing Plan, which describes the allocations and structure for West Coast halibut fisheries (tribal, commercial, and recreational), and the Department's monitoring, sampling, and coordination systems for these quota-managed fisheries.

#### 8. New Combination Recreational Fishing Licenses – Briefing, Public Hearing and Decision

Greg Sallis, Sales and Marketing Manager briefed the Commission on a proposed new WAC 220-55-165 to establish a reduced rate annual Fish Washington license, and the ability for anglers to upgrade to a combination or a new Fish Washington license and heard public comments before requesting approval.

### Commissioner Carpenter moved to adopt WAC 220-55-165 as presented and it was seconded by Commissioner Mahnken, all were in favor and the motion passed.

#### <u>9. Periodic Status Review (Taylor's Checkerspot Butterfly and Columbia White-tailed deer) –</u> Briefing, Public Hearing and Decision

Hannah Anderson, Listing and Recovery Section Manager, and Ann Potter, Wildlife Biologist, requested approval from the Commission on the Periodic Status Reviews compiled for the state listed species referenced above.

## Commissioner Carpenter moved to retain the Columbian White-Tailed Deer as endangered and the Taylor's Checkerspot as endangered as presented by staff, the motion was seconded by Commissioner Mahnken. Motion passed.

#### 10. Enforcement Program Update – Briefing

Deputy Chief Mike Cenci and Captain Dan Chadwick, Region 6 provided an overview of how they have focused on the agency goals through achieving the program's strategic objectives and list detailed accomplishments.

## 11. & 13. 2017 Wild Future Update and 2017 Legislative and Supplemental Operating Budget Requests – Briefing and Decision

Jennifer Quan, Governmental Affairs Director, Rachel Crosier, Legislative Liaison and Owen Rowe, Budget Officer briefed the Commission and requested approval to submit the 2017 legislative and operating budget packages as placeholders to Office of Financial Management.

Commissioner Carpenter moved to allow the Department to submit the 2017 legislative and operating budget packages to OFM as a placeholder recognizing that the package will continue to evolve over the course of the next several months in response to ongoing stakeholder conversations, seconded by Commissioner Thorburn. Motion passed.

#### 12. Capital Budget Request – Briefing and Decision

Tim Burns, Assistant Director, Capital and Asset Management Program provided an informational briefing and request approval on the agency's Capital Budget.

## Commissioner Carpenter moved to approve the proposed FY2017 – 2019 Capital Budget Request as presented, allowing for minor adjustments seconded by Commissioner Thorburn. Motion passed.

#### 14. Petition to Change Rules – Decision

Mick Cope, Deputy Assistant Director, Wildlife Program briefed the Commission on a petition regarding points for special permit hunts.

Commissioner Carpenter moved to deny the petition and directed the Department to evaluate the issue of point restoration, discuss the issues with stakeholders, and recommend rule changes to the Fish and Wildlife Commission with a report detailing the rationale for not recommending rule changes. The motion was seconded by Commissioner Wecker. Motion passed.
