MAKAH SPECIAL MANAGEMENT AREA OPENS TO STATE FISHERS

The Makah SMA, in the area between Destruction Island and the US Canada Border, will open to state fishers at 8:00 A.M. on February 15, 2014.

There will be a 200-pot limit in the SMA until 8:00 A.M. March 17, 2013 (the first 30-days following the opening of this SMA). Fishers must pre-register with WDFW **twenty-four hours** prior to deploying gear in this area. Fishers can pre-register by one of the three following methods:

The Makah SMA is described as the coastal waters between 48°02.15 N' Lat. to 48°19.50 N' Lat. east of a line connecting those points approximating the 25-fathom line according to the following coordinates:

•	Northeast Corner:	Tatoosh Island	
•	Northwest Corner:	48°19.50' N. Lat.	124°50.45' W. Long.
•	Southwest Corner:	48°02.15' N. Lat.	124°50.45' W. Long.
•	Southeast Corner:	48°02.15' N. Lat.	124°41.00' W. Long.

Details for the remaining SMAs have not changed since the letter we sent you on December 27, 2013. As a reminder those details are listed below.

SPECIAL MANAGEMENT AREAS:

Quinault:

The Quinault **primary SMA** will be closed to state fishers beginning at 8:00 AM January 15, 2014. The **primary SMA** is scheduled to remain closed to state fishers until 8:00 am on May 1, 2014.

The Quinault **primary SMA** is described as the coastal waters shoreward of a line approximating the 27-fathom depth curve between Raft River (47°28.00) and Copalis River (47°08.00) according to the following coordinates:

•	Northeast Corner (Raft River):	47°28.00' N. Lat.	124°20.70' W. Lon.
•	Northwest Corner:	47°28.00' N. Lat.	124°34.00' W. Lon.
•	Southwest Corner:	47°08.00' N. Lat.	124°25.50' W. Lon.
•	Southeast Corner: (Copalis River):	47°08.00' N. Lat.	124°11.20' W. Lon.

A Quinault **secondary SMA** (SSMA) will be established on 8:00 am May 1, 2014 to include the area shoreward of a line approximating the 27-fathom depth curve between the mouth of the Copalis River (47°08.00) and Split Rock (47°24.50) according to the following coordinates:

•	Northeast Corner (Split Rock):	47°24.50' N. Lat.	124°20.00' W. Lon.
•	Northwest Corner:	47°24.50' N. Lat.	124°32.40' W. Lon.
•	Southwest Corner:	47°08.00' N. Lat.	124°25.50' W. Lon.
•	Southeast Corner (Copalis River):	47°08.00' N. Lat.	124°11.20' W. Lon.

When the area between Split Rock and Raft River opens, state fishers must pre-register with WDFW prior to deploying gear in this area. Specific details regarding SMA openings and pot limits will be made available prior to opening.

Quileute:

The Quileute SMA is closed to state fishers beginning at 8:00 AM January 15, 2014. The Quileute SMA will open to state fishers beginning at 8:00 AM, May 1, 2014.

The Quileute SMA is described as the area from Cape Johnson to Destruction Island shoreward of a line approximating 30 fathoms according to the following points:

•	Northeast Corner (Cape Johnson):	47°58.00' N. Lat.	124°40.40' W. Lon.
•	Northwest Corner:	47°58.00' N. Lat.	124°49.00' W. Lon.
•	Southwest Corner:	47°40.50' N. Lat.	124°40.00' W. Lon.
•	Southeast Corner: (Destruction Island):	47°40.50' N. Lat.	124° 24.43 W. Lon.

There will be a 100-pot limit in the SMA from May 1, 2014, through May 31, 2014. Fishers must pre-register with WDFW prior to deploying gear in this area.
