Stock status and management guidelines for 2014 Spring Chinook fisheries were presented in Winter Fact Sheet #2 (January 29, 2014).

Stock Status and Management Guidelines

- Bonneville Dam passage through May 5 totals 119,758 adult Chinook. Based on the 10-year average the 50% passage date is May 7, ranging from April 27 to May 12.
- The U.S. v. Oregon Technical Advisory Committee (TAC) met Monday May 5 to review the status of the upriver spring Chinook run. TAC officially updated the run to a minimum of 185,000 adult fish. TAC will continue to meet weekly to review stock status and is scheduled to meet again Monday May 12.
- Under the *U.S. v Oregon* Management Agreement, a Columbia River return of 185,000 adult upriver fish allows for a non-Indian ESA impact rate of 1.9% and a catch balance limit of 16,835 upriver mortalities. Commission guidance directs managers to allocate the impacts 70% sport/30% commercial. ESA impacts increase for runsizes of 217,000 fish or greater.
- Adult spring Chinook passage at Willamette Falls through May 1 totals 3,423 fish, well below the 5-year average cumulative passage to date of 6,023 fish. The five year average 50% passage date is May 22.

Non-Indian Fishery Update

- A mainstem commercial salmon fishing period (8 hours) occurred on April 1. Chinook landings totaled 1,746 fish. Kept and release mortalities of upriver Chinook is estimated at 1,511 fish, or 49% of allocated.
- Mainstem commercial shad fisheries are open under permanent regulations in Area 2S from 3 PM to 10 PM daily Monday through Friday from May 10 through June 20 (except on the observed Memorial Day holiday). Additional shad harvest may also occur under an experimental permit issued by the state of Oregon
- Select Area fisheries are ongoing and expected to continue through June 13. Landings through May 2 total 1,434 Chinook. Upriver Chinook mortalities to date total 204 fish and are projected to total 278 fish for the season. In season action was taken on this fishery to reduce accumulation of upriver take.
- The lower Columbia River recreational fishery was open for Chinook retention through April 14, and re-opened for one additional day on April 19. Catch estimates total 11,056 kept and

2,652 released adult fish from 80.900 angler trips. Kept and release mortalities of upriver Chinook is estimated at 9,276 fish, or 85% of allocated.

- The lower Columbia River from the Tongue Point/Rocky Point line upstream to the I-5 Bridge will open May 16 for hatchery steelhead and hatchery jack Chinook. Shad retention opens May 16 from Buoy 10 upstream to Bonneville Dam under permanent regulations.
- The recreational spring Chinook fishery from Bonneville Dam upstream to the Oregon/Washington border is scheduled to be open through May 9. Catch estimates through Sunday May 4 total 1,174 kept and 434 released adult fish. Kept and release mortalities of upriver Chinook is estimated at 1,217 fish. Catch projections for May 5-9 total 700 additional kept plus release mortalities. The season total would be 1,917 fish or 131% of allocated.
- The recreational fisheries on the Snake River (Washington waters) are open on a days-perweek basis in four sections of the river. The fisheries are ongoing until the harvest allocation is met. Catch estimates through April 30 total 81 kept and 21 released adult fish. Kept and release mortalities of upriver Chinook is estimated at 83 fish or 8% of allocated.

• The treaty tribes have decided that commercial sales are appropriate for the on-going Zone 6 platform and hook and line fishery on the number of fish remaining available for harvest at the updated run size. For ease of regulations, this fishery runs continuously into the Summer Management Period.

Additional Rules:
Observer program: As a condition of fishing, owners or operators of commercial fishing vessels must cooperate with department observers or observers collecting data for the department, when notified by the observer of his or her intent to board the commercial vessel for observation and sampling during an open fishery. In addition, cooperation with department personal prior to a fishing period is expected.
Live Capture workshop: Only licensed Columbia River commercial fishers that have completed the required state-sponsored workshop concerning live capture commercial fishing techniques may participate in this fishery. At least one fisher on each boat must have live capture certification.
24-hour quick reporting required for Washington wholesale dealers, per WAC 220-69-240.

- The catch estimate is 1,600 to 1,800 hatchery Chinook based on an expected 100 to 120 deliveries. Upriver mortalities are estimated at less than 1,540 fish. Season total upriver mortalities would be 3,050 fish, or 98% of the total commercial allocation at the current minimum run size.
- Average weight of kept chinook is expected to be around 12 pounds per fish and ex-vessel value is estimated at \$ 5to \$7 per pound for Grade-A adult size fish.
- A Wednesday fishery avoids conflict with the Thursday night fisheries in most Select Areas.

Non-Indian Select Area Commercial:

• Based on the current run size, staff is recommending the following season modifications for Select Area fisheries which slightly liberalize season restrictions adopted in late April. These recommendations continue the conservative approach needed in order to manage available upriver spring Chinook impacts for the remainder of the season.

2014 Knappa Slough Select Area - Recommendation

Effective Thursday May 8: The lower boundary of the Knappa Slough fishing area is extended downstream to boundary lines defined by markers on the <u>west end</u> of Minaker Island to markers on Karlson Island and the Oregon shore (fall boundary).

2014 Tongue Point/South Channel Select Area - Recommendation

Modify the previously adopted fishing period (7 PM-1 AM) for Thursday night May 8 in Tongue Point to **9 PM Thursday May 8 through 6 AM Friday May 9, 2014**.

Youngs Bay Select Area Commercial Fishery- Oregon State Staff Recommendation

Modify the previously adopted fishing period (1-7 PM) for Thursday May 8 in Youngs Bay to <u>2-10</u> <u>PM</u>.

• Beginning May 12, Select Area fishing periods and hours revert to the seasons originally adopted at the January 29 Compact Hearing.

• Based on the remaining allocation for the area downstream of Bonneville Dam, the staff has outlined two options for consideration:

- to retention of Chinook, the salmonid daily bag limit in Oregon and Washington Select Areas will be the same as mainstem Columbia River bag limits. On days when the mainstem Columbia River fishery is <u>closed</u> to Chinook retention, permanent salmonid bag limit regulations apply
- The intent of Option 1 would be to use the remaining allocation to provide adult Chinook retention opportunity that would allow for the spring fishery to transition directly to the summer fishery without a retention break.
 - If this approach were preferred, the decision could be postponed until next week since the current available allocation is not sufficient to start the fishery right away. Staff estimates a minimum upriver run size of 216,500 would be needed to allow for Chinook retention May 16-June 15.
 - In past years, this approach has been favored when discussed at the Recreational Advisory Group.
- Option 2 would re-open Chinook retention for three days. Catch estimates include 1,400 Chinook kept (400 released). Upriver mortalities are expected to total 1,224 fish, bringing the total for recreational fisheries downstream of Bonneville Dam to 10,500 mortalities.
 - An additional 210 upriver mortalities need to be set aside for release mortalities associated with the steelhead fishery. This brings the combined total to 10,710 upriver fish or 98% of allocated.
- An upriver run size of at least 217,000 fish is needed in order to allow for a Chinook retention season as proposed in Option 2 *and* a Chinook retention season during May 16 through June 15.

2014 Mainstem Columbia River Spring Chinook Recreational Fisheries-Recommendation Upstream of Bonneville Dam

Effective Thursday May 8, 2014, close the ongoing recreational salmonid fishery in the mainstem Columbia River from Bonneville Dam upstream to the Oregon-Washington border. All other permanent regulations remain in effect

- Given the current upriver run size forecast, the recreational Chinook fishery upstream of Bonneville Dam is projected to exceed the available Chinook allocation. Closing the fishery 2 days earlier than scheduled is expected reduce the total upriver mortalities for this fishery to 1,637, or 112% of the current allocation.
- A run size of around 220,000 is needed to allow the fishery to continue as currently scheduled (through May 9).
