Treaty Commercial Winter Gillnet Fishery

STOCK STATUS

• Stock status information is available in Winter Fact Sheet #1 (January 31, 2017) and in the January 20, 2016 Winter/Spring/Summer Joint Staff Report and the 2017 Sturgeon/Smelt Report (January 30, 2017).

TREATY INDIAN FISHERIES

• The preliminary Zone 6 treaty commercial sturgeon harvests and commercial guidelines are shown in the table below. These catches include the fish recorded on fish tickets for Week's 6 through 8. No other species have been reported harvested.

- There was a setline fishery open in all three pools in January but no harvest has been reported. The winter gillnet fishery has harvested a total of 298 fish through Monday. No other species have been reported harvested to date. The fisheries in both the John Day Pool and The Dalles Pool are currently scheduled to close today at 6:00 PM (Wednesday March 1).
- The sturgeon catch per day continues to be below the recent year average rate for this time of year for the John Day Pool but has increased to above the recent average for The Dalles Pool. Catch rates generally increase as the season progresses.
- Tribal staff are projecting that catches this week will continue at least at the rates over the past few days and will likely increase this week. Based on these projections, tribal staff project the total John Day Pool catch to be approximately 260 on March 4 and The Dalles Pool catch to be approximately 290 on March 4. Based on these projections, both fisheries will still be within their commercial harvest guidelines by March 4.

• All four tribes agreed to the extension of the commercial fisheries in the upper pools and an opening in the Bonneville Pool as presented in the following table.

- The current regulations for the Zone 6 platform and hook and line fisheries do not require modification at this time.
- There is no specific guideline for treaty subsistence harvest of sturgeon, but these fish are accounted for.
- Tribal fishery monitors will monitor fisheries and assist in collection of biological data.
- State and tribal staff will work cooperatively to report harvest on a regular basis.
- Sturgeon fisheries will be closed earlier if harvest guidelines for that pool are met before the scheduled end dates.
- The tribes request another Compact to be tentatively scheduled in the late afternoon on March 20th in case an extension of the Bonneville Pool fishery is appropriate.
