Columbia River Compact/Joint State Hearing March 19, 2019

Fisheries Under Consideration: Treaty commercial gillnet

Detailed information on stock status and management guidelines for Columbia River fisheries are presented in Joint Staff Reports, which are produced annually and available on-line. STOCK STATUS

Sturgeon

- Sturgeon stock assessment information was presented in Winter Fact Sheet #1.
- The 2019 sturgeon commercial harvest guidelines for Treaty fisheries in Zone 6 are 500 fish for the Bonneville Pool, 415 for The Dalles Pool, and 175 fish for the John Day Pool.
- There is not a specific harvest guideline for the treaty subsistence catch of sturgeon, but these catches are accounted for and used in population assessments. Subsistence harvest typically occurs in association with fisheries targeting other species and is generally low. In 2018, the subsistence harvest was just 89 in all three Zone 6 reservoirs combined.

RIVER CONDITIONS

- The current water temperature at Bonneville Dam is gradually warming but is still only 39 degrees F.
- Flows yesterday at Bonneville Dam were just under 130Kcfs which is lower than average for this time of year but not outside of the range in the last 10 years.

2019 TREATY INDIAN WINTER FISHERIES

- A setline fishery occurs each January in all three Zone 6 pools under permanent regulations. This fishery generally has low effort and catch.
- The tribes typically set winter season gillnet fisheries during the period between February 1 and March 21. In 2018, the fishing period was extended to March 24.
- The tribes set initial winter season gillnet openings through February 13 in the two upper pools based on past catch rates. The fisheries were extended until 6:00 PM on February 19. The John Day Pool fishery was further extended until February 27. The Bonneville Pool fishery began on March 1 and is currently scheduled to close on March 20. Catch rates generally start out slow and increase over time as water temperature and effort increase.
- Preliminary Harvest information through March 18 is shown in the table below.

- The winter steelhead count at Bonneville totals 1,100 from November 1 through March 16. The spring chinook count is 3. The public should anticipate some delay in the public distribution of dam counts from the Federal Hydro-power projects as the USACE transitions to a new contractor that will be making the counts.
- Two steelhead and no salmon have been harvested to date.
- The tribes have updated our modeled catch for the commercial gillnet opening in the Bonneville Pool. Catch rates to date have remained moderate. Even if catch rates increase this week, tribal staff do not expect the guideline will be reached by March 23.
- The four Columbia River treaty tribes will or have adopted regulations consistent with the following:

• In January the Compact took action on the Zone 6 Platform and Hook and Line fishery which allowed commercial sales through March 21st. Because the tribes are extending the winter gillnet fishery through March 23, allowing sales for the Zone 6 platform and hook and line fishery should also be extended through the same time period for consistency.

- Tribal staff will work with state staff to monitor the catch and account for commercial fish tickets along with any direct to public sales and report total harvest.
- The tribes will assess the sturgeon harvest totals along with their spring ceremonial permit fishing plans and will notify the states if any additional winter gillnet fishing time is appropriate. Typically, the tribes begin ceremonial permit fishing about the last week in March.

FUTURE MEETINGS

• The treaty tribes will notify the states if a Compact Hearing is needed in the near future to address treaty fisheries.
