

### **NON-FATAL INCIDENTS**

#### Cause: Failure to maintain muzzle control

Shooter:	28 year old male	Victim:	Self

Shooter was loading his truck for the afternoon hunt and grabbed his muzzleloader which got caught on a part of the truck discharging the firearm into his forearm.

## Cause: Failure to identify what lies beyond before firing

Shooter was shooting at deer in the direction of a neighbor's house. The slug entered the neighbor's house and struck the female neighbor in the knee.

#### Cause: Failure to maintain muzzle control

Shooter placed his shotgun on the ground to retrieve a pheasant from his dog. His hunting partner came to his location and the excited dog stepped on the shotgun, discharging it into the victim's foot.

#### **Ten Firearm Safety Rules**

- 1. Always keep the muzzle pointed in a safe direction and under control.
- 2. Treat every firearm as if it were loaded.
- 3. Keep your finger off the trigger until ready to fire. Use your safety, but remember that safeties sometimes fail.
- 4. Be sure of your target and what lies beyond before firing.
- 5. Never place or carry a loaded firearm in a motor vehicle.
- 6. Never use a firearm unless you are familiar with how it works. If you need an owner's manual, write to the manufacturer.
- 7. Never cross a fence, climb a tree, cross a stream or jump a ditch with a loaded firearm.
- 8. Never point at anything you do not want to shoot.
- 9. Unload firearms when not in use. Store firearms and ammunition separately.
- 10. Never use alcohol (or drugs) before or during shooting.
